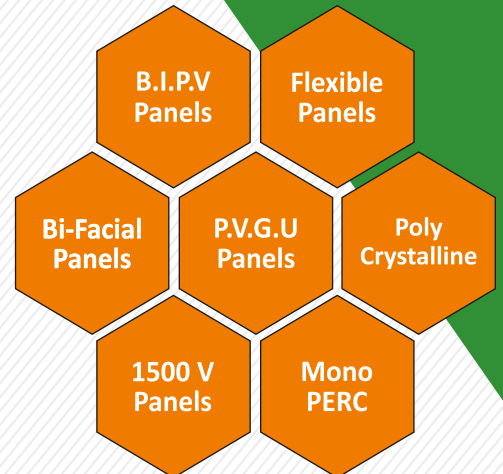

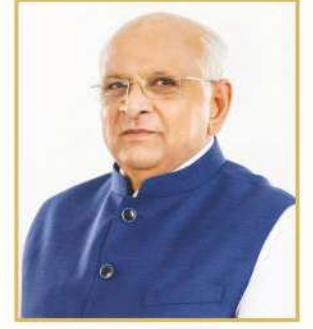

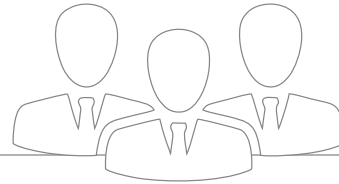

Virtual Management

123



In Today's Business, it is very difficult to sit in the office and Manage Team. The Present business needs and infrastructure do not allow you to sit and handle business. Today there is a paradigm shift to Virtual Management.

While the management structures and systems developed by such researchers as Weber, Fayol, Taylor and Drucker in the 19th and 20th centuries established a management paradigm which has endured up to the millennium, these "simple" structures and systems were more suited to a time when competition was slower, less aggressive, and characterized by long periods of stability, and when information science was in its embryonic or primordial stage. It is abundantly clear, however, that the arrival of the 21st Century demands a fundamental rethink, and the development of a management paradigm that can withstand the pressure of rapid change in a borderless, connected and wired world, relying more and more on virtual structures - **a virtual management** system.

New technologies have led to a new information/ knowledge-based economy, in terms of which organizations have become increasingly complex. The technologically induced emergence of a "virtual" environment has resulted in the adoption of new organizational structures /and work practices, and has created several management and leadership challenges for the traditional twentieth century management paradigm.

The emergence of such technologies as e-mail, the Internet, telecommuting, and voice mail has spawned such products as the **virtual office**, the **virtual company** and **virtual teams**. The effective and efficient operation of these products, however, requires closer scrutiny in order to understand the organizational code involved, that is, the discovered order of the organization.

The Business Leaders or the Business Heads have to move to various places and time for having controls on the work carried out by team is very difficult if he is not there in the office. In this scenario, not only the IT peripherals or any web based technology will help but also it is necessary to have controls virtually by putting various checker and maker concept in the organisation.

This controls will enable Business Heads to have Virtual controls. For example the Clear SOP on Purchase right from Indent- Quotation-Purchase order-GRIN-QC-Acceptance-Bills –Payment and maker and checker of these document will make activity full proof.

The importance of Virtual Managers and growth of Virtual Managers are more than any ordinary manager who believe on to checking all the transactions by himself.

Tax Deducted at Source on benefits or Perquisites (Section 194 R), Applicable from 1st July 2022

Preamble:

Till the introduction of this Section, the Benefits or Perquisites given by the Companies to the Various persons like, Sales Team, Doctors in case of Pharma Companies, Agents in case of many FMCG or B2B Companies, Leisure Trip to the certain class of Agents, Pre or post Stay before or after the conference meetings etc. Companies were claiming as an expense, but it was going untaxed in the hands of the receiver of the benefits. To curb this, Honorable FM in her speech informed that such transactions would have 10% TDS unless it is below Rs. 20000/- in a year. This is applicable from 1st July 2022.

Section 194R in Detail:

The new section mandates a person, who is responsible for providing any benefit or perquisite to a resident, to deduct tax at source @ 10% of the value or aggregate of value of such benefit or perquisite, before providing such benefit or perquisite. The benefit or perquisite may or may not be convertible into money but should arise either from carrying out of business, or from exercising a profession, by such resident.

This deduction is not required to be made, if the value or aggregate of value of the benefit or perquisite provided or like ly to be provided to the resident during the financial year does not exceed twenty thousand rupees.

The responsibility of tax deduction also does not apply to a person, being an Individual/Hindu undivided family (HUF) deductor, whose total sales / gross receipts / gross turnover from business does not exceed one crore rupees, or from profession does not exceed fifty lakh rupees, during the financial year immediately preceding the financial year in which such benefit or perquisite is provided by him.

Sub-section (2) of section 194R of the Act authorizes the Board to issue guidelines, for removal of difficulties, with the approval of the Central Government. These guidelines are required to be laid before each House of Parliament and are binding on the income-tax authorities and the person providing the benefit or perquisite.

Now let us go thru the guidelines issued by way of Circular No. 12 of 2022 dated 16th June 2022. There are 10 Questions they have given as a most likely questions and given the clarification on the same. These are as listed and explained below:

1. Whether Payer need to check whether the Benefits/Perquisites given is falling under section 28 (iv)?

No. The deductor is not required to check whether the amount paid as perquisites will be taxable in the hands of Receive under section 28 (iv). Section 194R of the Act casts an obligation on the person responsible for providing any benefit or perquisite to a resident, to deduct tax at source @10%. There is no further requirement to check whether the amount is taxable in the hands of the recipient or under which section it is taxable.

2. *Whether it should only in Kind ?*

The intent of legislature that there could also be situation where benefit or perquisite is in cash or the benefit or perquisite is in kind or partly in cash and partly in kind. Thus, section 194R of the Act clearly brings in its scope the situation where the benefit or perquisite is in cash or in kind or partly in cash or partly in kind.

3. *Whether TDS is deductible even in case benefit is given in case benefit/ perquisites is given by way of Capital Assets?*

Yes. The deductor is required to deduct tax under section 194R of the Act in all cases where benefit or perquisite (of whatever nature) is provided. So even in case of Capital Assets, TDS will be attracted.

4. *Whether sales discount, cash discount, and rebates are also covered under section 194R?*

It is very cumbersome to calculate TDS Sales Discount, Cash discount, One Item free on Two purchase etc. So although it is a benefit, this is kept aside the ambit of section 194R.

5. *What is the Valuation Rule in case of benefit/perquisites?*

- a) If the benefit/Perquisites provide has purchased and then issued, Purchase cost.
- b) If the benefit/Perquisites provide has manufactured and then issued, then the price that it charges to its customers for such items shall be the value for such benefit/perquisite.

6. *What about Products given for promotion of a product by a manufacturer?*

In case the product is used for promotion purpose and kept by the person, it will be treated as perquisites and tax is required to be deducted accordingly under section 194R of the Act.. If the Product is returned to the Benefit provider, then it will not be treated as a benefit/perquisite for the purposes of section 194R of the Act.

7. *Whether Reimbursement of expenses incurred by Service provider in course of rendering Service is benefit/perquisites?*

There are two cases in this.

- 1. If the Invoice is in the name of Company (Say "X") and paid by the receiver of the benefit (Say "Consultant") and then taken as reimbursement, it will not be treated as perquisites.
- 2. If the Invoice is not in the name of "X" and it is paid by consultant or reimbursed from "X", it will be taken as a perquisites for which deduction is required to be made under section 194R of the Act.

8. *Whether dealer conference is benefit/perquisites ?*

If the same is given to the masses, no benefit/ Perquisites. If it is to the class of People, then it will be taken as perquisites.

The expenditure pertaining to dealer/business conference would not be considered as benefit/perquisite for the purposes of section 194R of the Act in a case where dealer/business conference is held with the prime object to educate dealers/customers about any of the following or similar aspects:

1. new product being launched
2. discussion as to how the product is better than others
3. obtaining orders from dealers/customers
4. teaching sales techniques to dealers/customers
5. addressing queries of the dealers/customers
6. reconciliation of accounts with dealers/customers

However, such conference must not be in the nature of incentives/benefits to select dealers/customers who have achieved particular targets. Further, in the following cases the expenditure would be considered as benefit or perquisite for the purposes of section 194R of the Act:-

1. Expense attributable to leisure trip or leisure component, even if it is incidental to the Dealer business conference.
2. Expenditure incurred for family members accompanying the person attending dealer business conference
3. Expenditure on participants of dealer/business conference for days which are on account of prior stay or overstay beyond the dates of such conference.

9. *What about TDS collection/Payment in case the benefit is given in Kind and Cash and cash is not enough to cover the TDS?*

It is the responsibility given to the receiver of the benefit to arrange fund in case it is in kind to provide for payment of TDS in advance and inform the payer of benefits/perquisites about the same.

10. *How the limit of twenty thousand is to be computed for the FY2022-2023?*

- a) Threshold is Rs. 20000/- for the year. So it is to be calculated from 01/04/2022 to 31/03/2023.
- b) The benefit or perquisites has been provided on or before 30th June 2022, would not be subjected to tax deduction under section 194R of the Act.
- c) Provision of Section 194R shall apply with effect from 01/07/2022.

Conclusion :

It is advisable to maintain proper data of such transactions where the benefits/perquisites are passed on to the certain people like agents, Doctors, Sales Reps etc. so that TDS can be deducted and the expenses can be claimed. Although it is difficult but advisable to open various accounts in the accounting system in to fetch the attention of the deductor of TDS to separate it out such transactions from normal transactions to avoid the issues of lapse in payment of TDS under section 194R.

SANAND INDUSTRIES ... DUAL TAXATION ... A BOON OR A CURSE ???

Any and all patriotic citizens would appreciate that collecting taxes and fees is a fundamental way for any state government / statutory authorities to generate revenues that make it possible to finance investments in human capital, industrial and allied infrastructure, and the provision of services for citizens and businesses across the entire spectrum and thereby, not only infuse momentum to the process of overall development but enhance the standard of living of the citizens.



BUT against this, when a state government in an obnoxious manner and without any justifiable rationale, vehemently levies dual taxation on its industrial units and business houses, It is quite alarming and a matter of serious concern for one and all concerned.

Just to cite an example, the industrial units regularly pay Property Tax to the relevant local authorities, namely, Gram Panchayat, Nagar Palika, Corporation etc. without any facilities like water supply, common street lights, roads, drainage systems etc. in quid pro quo (in exchange of tax amount so received) from those authorities. In fact, providing such prime infrastructural facilities to industries is their primary obligation ...needless to state. As a result, the industries in G.I.D.C. are left with no alternative but to arrange those facilities for them to function and survive at their own cost through various industrial associations by paying applicable service charges!! ... Truly pathetic isn't it ??

Despite repeated oral and written requests and presentations at all levels in G.I.D.C. / Government of Gujarat by SIA over the last more than 3 years, we at Sanand Industries Association (S.I.A.) were left in lurch and had to resort to a legal course of action by filing a petition before the Hon'ble High Court of Gujarat, Ahmedabad. Accordingly, we had filed the petition under the name of Federation of Industrial Association (F.I.A.). The matter is on the board and a detailed hearing is expected shortly.

We, at S.I.A. function with a positive motto of working and progressing together to ensure a win-win situation for one and all without creating any stumbling blocks for any one. Hence, despite the matter being pending before the Hon'ble High Court, we have continued our efforts to solicit an amicable resolution with G.I.D.C. / Government of Gujarat in this matter of very serious concern. 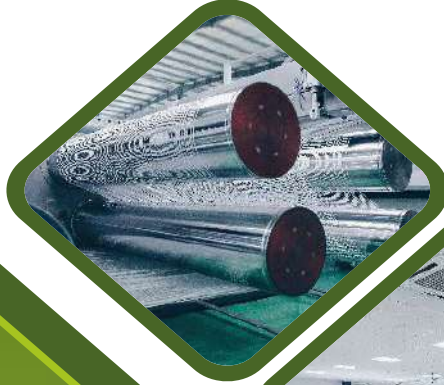

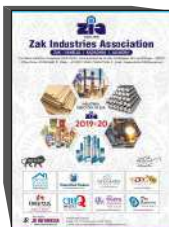
